PENSIONS - Contributory Pension Scheme - Extension of benefits of 'Retirement Gratuity and Death Gratuity' to the State Government employees covered by Contributory Pension Scheme (National Pension System) — Orders issued.

1. G.O.Ms No.653, Finance (Pension) Department, dt. 22.9.2004 .
2. O.M. No.7/5/2012; P&PW(F)/B, dated 26.8.2016 of Ministry of Personnel Public Grievances & Pensions, Department of Pension and Pensioners Welfare.

ORDER

In the G.O. 1<sup>st</sup> read above, the Contributory Pension Scheme was introduced with effect from 01.09.2004 to all State Government employees who are recruited on or after 01.09.2004. The employees covered under Contributory Pension Scheme are excluded from the applicability of T.S. Revised Pension Rules 1980, Accordingly, employees covered under Contributory Pension Scheme are not eligible for benefit of Gratuity.

2. In the reference 2<sup>nd</sup> read above, the Government of India allowed the benefit of 'Retirement Gratuity and Death Gratuity' to the Government employees covered by National Pension System on the same terms and conditions, as are applicable to employees covered by Central Civil Service (Pension) Rules, 1972.

3. Several representations were made to the Government to extend similar benefit as allowed by the Government of India i.e., 'Retirement Gratuity and Death Gratuity' to the Government employees covered by Contributory Pension Scheme (National Pension System) in the State.

4. Government, after careful consideration, hereby extend the benefit of Retirement Gratuity/ Death Gratuity to all the employees as mentioned in the G.O.Ms.No.653, Finance (Pen.I) Department, dated.22.09.2004, covered by the Contributory Pension Scheme (National Pension System) on the pattern applicable to employees governed by the Telangana Revised Pension Rules, 1980.

5. These orders are applicable to those Government employees who joined Government service on or after 01.09.2004 and are covered by Contributory Pension Scheme and shall take effect from the same date i.e., 01.09.2004.
6. The necessary amendment to the Telangana Revised Pension Rules, 1980 and the guidelines for drawal of amounts as per this order will be issued separately.

In the reference 1<sup>st</sup> cited, Government have issued orders extending the benefits of Gratuity and Death Gratuity to the State Government employees who are covered by CPS (NPS) and it was also ordered that operational guidelines shall be issued separately.

2. In the reference 2<sup>nd</sup> cited the DTA, Telangana, Hyderabad has proposed the guidelines for the smooth implementation of extension of Retirement Gratuity and Death Gratuity to the State Government employees covered by CPS (NPS).

3. Government after careful examination of the matter hereby issue the following operational guidelines for extending the benefits of Retirement Gratuity and Death Gratuity to the State Government employees who are covered by CPS (NPS).

**1. Calculation of Retirement Gratuity and Death Gratuity:**

As per the provisions and conditions prescribed under TS Revised Pension Rules 1980 from time to time.

**2. Authorities competent to sanction DCRG:**

As per the delegation or powers sanctioned in G.O. Ms. No. 208 Finance (P.S.C.) Department dt. 04-06-2010 and as per the further orders issued, if any, from time to time.

**3. Authorisation of DCRG**

- The DDO shall forward the Application Form for Retirement Gratuity as prescribed in the G.O.Ms.263, Finance (PSC) Department, dated.23.11.1998 along with Service Register of the employee concerned.
- The Accountant General (A&E), Telangana shall be the competent authority, to issue authorisations for Death Cum Retirement Gratuity to the State Government employees covered by CPS (NPS) and their family members.
- The Audit Officers of the State Audit Department in each District and in the case of Headquarters the Audit Officer working in the Office of the Director of State Audit, Hyderabad shall be the competent authority to issue authorizations for Death Cum Retirement Gratuity in respect of Class-IV and other low paid employees i.e., Police constables, Head constables, Excise constables & Forest guard etc.

**4. Apportionment of expenditure between the successor states:**

In respect of the Government Servants covered under CPS (NPS), who were appointed prior to 02-06-2014, the AG, AP & TS shall issue authorisations for Retirement Gratuity and Death Gratuity "duly apportioning the amounts as per the "Part - C" approved by the Pension Sanctioning Authority.

4. The DTA, Telangana, Hyderabad, the DSA and all the Heads of Department, Head of Offices are requested to follow above instructions scrupulously for drawing the Retirement Gratuity and Death Gratuity to the State Government employees covered by CPS (NPS).
